- 4. Teachers will submit reflections from their coaching cycle and their additional coaching activities.
- 5. Teachers will attend weekly collaboration/PLC as provided by the JSD Board of Education.
- 6. Teachers will submit a brief reflection and evidence of learning to their JPAS administrator.

Action Plan Steps

- 1. Communicate the expectation to the entire faculty.
- 2. Retrain on common assessments.
- 3. Invite faculty to share what they are using to collect data. Make a decision on how each content area team with collect and analyze data.
- 4. Create and use a systematic way for teachers to submit reflections from their coaching cycle and the other additional coaching activities.
- 5. Refine systematic recording of PLC attendance, minutes, and agendas.
- 6. Refine the collection of reflections and evidence of learning from teachers to JPAS administrator.
- 7. Provide time for teachers to work outside of contract time on planning and creating common assessments and refining curriculum.
